METHODOLOGY OF THE INVENTORY ON DONOR SUPPORTED ENVIRONMENTAL ACTIVITIES

Background

This report forms part of the Environmental and Disaster Relief Fund (EDRF) Programme Support Document submitted to Danida in February 1998. A draft of the Overview was submitted to the Informal Donor Group on Environment in Dar es Salaam in December 1997. The donors were asked to comment on the Overview and their corrections were following incorporated in the overview.

Collection of Information

The information compiled in the overview has been collected through meetings held with donors, NGOs and government institutions involved in environmental activities throughout October and November. In this work, the report 'Donor Supported Environmental Activities in Tanzania' from 1995 has been a very useful tool and point of departure for the meetings. Furthermore, complementary information from newspaper articles and reports has been added to the compilation.

The Thematic Areas

All the different programmes/projects have been placed under one thematic area. The chosen thematic areas follow the prioritised thematic areas in the EDRF strategy. In the overall overview some specific geographical areas or specific institutions have been selected to illustrate ongoing activities for these. The aim to place each project under only one thematic area proved to be difficult. Many of the projects encompass several components that make them fit under several thematic areas. In these cases, it has been estimated in each case what the main component of the project is and the project has following been placed under the thematic area of that main component. One example is the many forest management projects in different areas of the Eastern Arc Mountains. These projects fall under both the thematic areas 'Agriculture and Forestry', 'Biological Diversity' and 'Institutional Capacity Building'. However, as forest management is the main component, the projects have been placed under the thematic area 'Agriculture and Forestry'.

It should be mentioned that the thematic area 'Agriculture and Forestry' only includes agricultural projects with a forestry component and 'pure' forestry projects. 'Pure' agricultural projects (under which e.g. integrated pest management would fall) can not be funded by the EDRF and therefore they have not been included in the overview.

The thematic area 'Coastal Zone Management' is understood broadly encompassing all projects that deal with management of resources along both coasts and the great lakes. Projects on the great lakes in Tanzania have thus been included under this heading.

Water Resources is one of the thematic areas selected for support by Danida and Danced but it does not appear in the Overview as a separate heading. The Team decided not to treat Water Resources as a separate entity because projects dealing with water resources fall under one of the other thematic areas one way or other and were more easily structured in this way.

Methodology and Currency Rates

The Overview

The numbers in the first overview of all donor supported activities correspond to number of projects of the donor in question under the thematic area. If a donor runs the same activity in several regions, each regional project has been counted as one separate project. The projects in pipeline (p) have been approved and are ready to be embarked on. The project ideas (i) have not yet been approved. Some are only very preliminary ideas and visions for future activities. To know the current status of a project, the comments in the detailed lists on the projects must be consulted.

Conversion of Currency Rates

Contents of the Report

Included in the Report is an overall overview of all donors and how many projects each donor is involved in within the different thematic areas. This is followed by detailed information on all ongoing and future projects within each thematic area. Lastly a map of Tanzania'a Game Reserves and National Parks is provided together with an illustration of which donors are involved in different National Park or Game Reserve.
